## **PUBLIC PARTICIPATION**

Dr. Ann Marie Mulready, representing our organization (CARR) addressed the Board regarding the inadequacies in H.B. 6620, An Act Concerning the Right to Read and Addressing Certain Opportunity Gaps and Equity in Public Schools. (The statement is posted on the CARR website.)

Chris Drewery, Treasurer for the AACTE-CT and Dean of the School of Education and Professional Studies at Eastern CT State University, expressed concerns regarding the cost to preservice teachers for assessments and certification fees. AACTE is proposing that the state mitigate this burden by providing retake waiver codes, edTPA submission vouchers, a minority teacher incentive program, scholarships, TEACH grants and school internships, assistantships and residency positions.

Jane Gagne, PhD, sent a statement requesting that the CSBE provide policy to protect students from standardized testing during the pandemic

### **ITEMS FOR DISCUSSION**

A. <u>CAPSS Blueprint to Transform Connecticut's Public Schools.</u>
Fran Rabinowitz, Executive Director of the CT Association of Public-School Superintendents, presented the Association's, *Blueprint to Transform CT Public Schools.* The Blueprint provides a comprehensive set of 30 recommendation to transform the State's Equity Cost Sharing Grants and create more equitable funding across the state. The Association claims that the plan is comprehensive and long term, predictable and sustainable, coherent and interrelated,

innovative and efficient, demanding and accountable, and realistic and aspirational. The plan is designed to be fully operational over the course of 15 years in order to provide for a smooth transition from the present system of awarding cost sharing grants.

Following the presentation, members of the Board asked about the Plans consistency with the CSBE Five Year Education Plan, currently being developed. According to Rabinowitz, and Paul Freeman, much of plan is consistent and they offered the cooperation of CAPPS coordinating the plan with the CSDE.

# Agency Update,

Kathy Demsey, CFO, provided an update on the requirements for spending the Federal Cares Act Funds and the status of the CSDE support for the distribution of ESSER II funds. John Frasanelli, Department Health, Nutrition and Family Services, reported on the adoption of the Devereaux Strengths Assessment (DESSA) as a screen for Social-Emotional Health. The DESSA was determined to be the most comprehensive instrument and will be available to 100 districts for the 2021-2020 and 200 schools in the 2022-2023 school years at no cost. Chief Performance Officer, Ajit Gopalakrishnan reported that 70% of districts were operating as completely in-person models and that only 5 districts remain fully remote. Lastly, the Department is partnering with CAPPS to provide Professional development for districts to support family engagement.
